## **Overview – Context**

2021 preparation of Eurograduate II
2021 National Reference Point of GT

2020 conception proposal 2020 discussions with stakeholders 2020 focus and (in)formal groups 2021 continuous implementation 2021 conception presenation

Roadmap 2021 (+)

- 12 final targets / tens of activities (previously planned, semifinished, new)
- tens of stakeholders involved



# General Benefits of the Roadmap

- More (up-to-date) realism based on information sharing from topdown and bottom up approach and cross-resorts discussions
- Rethinking of compentences and responsibilities of stakeholders in GT
- Sorting out of targets and activities of different importance and time priority



# Examples of Activities / Targets in Progress

### European level

• Eurograduate proposal

systematic work of Ministry of Education, Youth and Sports

### National level

• Conception of national GT (admin data + surveys) and its step by step implementation

### Supporting both of the levels (in general)

- to involve more HR employees and other professionals
- to inform and communicate with stakeholders (different levels and sectors)
- to make the environment more predictable (coordination of surveys)
- to change ad hoc cooperation into regular activities if mutually advantageous
- to support networking and experience sharing, etc.

based on top down + bottom up approaches



# European Level Eurograduate Pilot Survey II

- Top priority of the European dimension of GT in CZ.
- Among other preparation activities discussions on the previous Eurograduate pilot survey (team members / selected HEIs' GT specialists / MEYS / others)
  - mainly expected benefits for HEIs,
  - coordination of (inter)national / institutional surveys,
  - specifics of Eurogradaute survey, etc.
- Getting the feedback usable for the improvement and writing a project proposal.



## National Level Conception Implementation

- Gradaute tracking information system
- Connection of administrative data (through an agenda indetifier of a natural person)
- Examination of preparedness of the public authorities concerned (Ministry of Labour and Social Affairs, Czech Social Security Administration, Ministry of Finances) in progress
- Legal analysis in progress (mandate to data use, responsibility towards the data subject)
- Plan of surveys suitable for graduate tracking
- Pilot moduls for user's groups (applicants)



## **Supporting Activities / Targets** *Community of HEIs' GT Professionals*

- Above formal communication (Rector' Conference, Council of Higher Education Institutions, MEYS conference, etc.) a need to interact with GT specialists at HEIs on more regular basis.
- Community of HEIs professionals is being developped platform for communication, networking and experience sharing.
- Series of seminars / workshops on GT topics (III-VI. 2021), *Experience with building alumni clubs, Graduate tracking – European level*, etc.
- Valuable presentations e.g. by the members of the expert group Eric Carver (Finland), Valerie Harvey (Ireland); Masaryk University; Charles University and others.
- Getting valuable feedbacks.
